



CONTEST RULES

1- TERMS AND CONDITIONS OF PARTICIPATION

3 - METHOD OF AWARDING PRIZES

Entries will be evaluated anonymously, using an evaluation grid. The jury will nominate the winners.

Provided the selected participant has met all the above conditions, he or she will be notified by e-mail or telephone that he or she has won, and his or her contact information will be validated. The Prize Sponsor cannot be held responsible for any failed attempt to contact a selected participant.

If the selected participant cannot be reached by e-mail or telephone within forty-eight (48) business hours of nomination, he/she will be deemed to have declined the prize and will be declared ineligible. Another entrant will then be selected from the remaining eligible entries.
